I. Legal Frameworks of Both the Organizations

Kanchrapara College, UGC approved NAAC Accredited (B+ Grade) Government of West Bengal Aided College affiliated to University of Kalyani, having its office at Kanchrapara, District North 24 Parganas, West Bengal – 743145, being represented by its **Principal Prof. (Dr.) Pranab Kumar Bera** herein after referred to as the **FIRST PARTY**;

Sudhiranjan Lahiri Mahavidyalaya, UGC approved NAAC Accredited (B - Grade) Government of West Bengal Aided-College affiliated to University of Kalyani, having its office at Majdia, Nadia, West Bengal –741507, being represented by its **Principal Prof. (Dr.) Dipankar Ghosh** herein after referred to as the **SECOND PARTY**.

II. Purpose of the Agreement

Both the parties are pleased to enter upon an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions through following but not limited to:

1. The exchange of faculty to the mutual benefit of both institutions;
2. Collaboration in teaching and learning in the field of mutual interest;
3. The exchange of academic materials and publications;
4. Conducting lectures;
5. Participating in seminars and other types of academic discussions;
6. Conducting study tours and joint consultancy work;
7. The Parties through mutual consultations and agreement will discuss and agree upon additional responsibilities, if any;
8. There will be no financial involvement by neither of the parties.
9. Any other activity that is mutually agreed upon and is beneficial to both.

III. Execution of the Agreement

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, period the sub-agreement will be in effect, and administrative responsibility within each institution.

IV. Term and Expiration of the Agreement

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of **Five years**. After these **Five years** it will be automatically extended for same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and expiration of this MoU will not affect

Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

V. NON-EXCLUSIVITY:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

VI. SPECIAL PROVISIONS

1. Each party will take approval from the other party in writing prior to using the latter's name and logo for the activities hereunder on a case-by-case basis.
2. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
4. Neither party can misuse this MoU by involving the name of the other without the written consent from the other party.

VII. DISPUTES

If any dispute aris in respect of the MoU, in that case both the organisations will discuss and settle the matter amicably.


