Parties to the Agreement and the Legal Framework:

The Memorandum of Understanding (MOU) is entered into on this 09<sup>th</sup> June, 2023 towards the establishment of an Agreement by and between:

**SUDHIRANJAN LAHIRI MAHAVIDYALAYA**, a Government Sponsored Undergraduate Degree College located at Majdia, Dist.-Nadia, PIN-741507, State: WEST BENGAL, INDIA established in 1966 referred to as **SUDHIRANJAN LAHIRI MAHAVIDYALAYA**, affiliated to the University of Kalyani, represented by its Principal and referred to as **FIRST PARTY** (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office representatives, administrators and assigns) for the exchange of Staff for purely academic and Social Work Purpose.

AND

**Indian Red Cross Society, Krishnaganj Block Unit, Vill- Naghata (Laxmidanga Road), P.O.: Majdia, District: Nadia, Pin - 741507, West Bengal**, Represented by its Secretary & referred to as **SECOND PARTY**.

*Note: Both these institutes will be hereafter referred to as Parties.*

Vision of the Agreement:

1. First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
2. Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;
3. The Major activities between the two organisations will centre around Blood Donation.

(a) An awareness program will be organized at Sudhiranjan Lahiri Mahavidyalaya with the help of Indian Red Cross Society.

b) The Blood groups of the students, faculty members and employees will be identified by the Red Cross and a directory for the same will be published by Sudhiranjan Lahiri Mahavidyalaya.

c) A special drive for girl students of Sudhiranjan Lahiri Mahavidyalaya will be launched for creating awareness related to anemia.

4. The Indian Red Cross Society will Sudhiranjan Lahiri Mahavidyalaya in creating health awareness at the adopted villages.

5. Routine immunization camps will be organized in association with Red Cross at the adopted villages.

6. That all two parties will work within the mandates of each organization and adhere to the broad principles of humanitarian action as followed by the Red Cross Movement worldwide, namely, Humanitarianism, Impartially, Neutrality, Independence Voluntarism, Unity and Universality.

7. That the collaboration will be with the following broad objectives:

- a. Building the resilience of communities to disaster and climate change.
- b. Strong emphasis on disaster risk management on natural, manmade hazards and related environmental, technological and health hazards and risk.
- c. Preventing new risk, reducing existing risk and strengthening resilience.

8. That the focused areas of collaboration will be following:

- a) Disaster risk reduction, mitigation and preparedness.
- b) Water sanitation and hygiene promotion (WASH).
- c) Climate change adaption.
- d) Environmental management and restoration.
- e) Ecosystem based livelihood support.
- f) Health and blood services.
- g) Any other area of mutual interest

9. Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

10. The general terms of cooperation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

11. Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein.

12. There is no financial commitment on the part of the First Party to take up any program mentioned in the MOU. If there is any financial consideration, it will be dealt separately.

13. Nothing contained in this MOU shall, by express grant, implication, estoppel, or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copyrights and designs) of the other Party.

#### VALIDITY

1 This Agreement will be valid for a period of 5 years up to 9th June 2023 from the date as governed by this MOU until it is expressly terminated by either Party on mutually agreed terms, during which period, **Indian Red Cross Society** the Second Party, as the casemay be, will take effective steps for implementation of this MOU. Any act on the part of **Indian Red Cross Society**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.

2. Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

1. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MOU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of KOLKATA.
