

MEMORANDUM OF UNDERSTANDING



This **Memorandum of Understanding** (hereinafter called as the 'MOU') is entered into on the 28th of May 2023.

BETWEEN

Sudhiranjan Lahiri Mahavidyalaya, Majdia, Nadia, West Bengal-741507 represented herein by its Principal (hereinafter referred to as 'First Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators, and assigns).

AND

SUCCESS SCHOLAR, the Second Party, and represented herein by its Zonal / Divisional Head, Director/Proprietor/Business Owner(hereinafter referred to as "Second Party", company which expression, unless excluded by or repugnant to the subject or context shall include its successors – infffice, administrators and assigns).

First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

2. The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.

 Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;

- 4. SUCCESS SCHOLAR, the Second Party is engaged in Skill Development, Education and R&D Services in the field of SOFT SKILLS, LIFE SKILLS, LANGUAGE AND COMMUNICATION SKILLS, CORPORATE COMMUNICATIONS, INTERPERSONAL RELATIONSHIPS, EMOTIONAL INTELLIGENCE, LEADERSHIP SKILLS, HEALTH AND HYGIENE, GROOMING AND BODY LANGUAGE.
- SUCCESS SCHOLAR the Second Party is promoted by SUDHIRANJAN LAHIRI MAHAVIDYALAYA, Majdia, Nadia, West Bengal 741507

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 The Second Party will provide time-to-time training and updates in the field of Soft Skills Development so that the First Party can impart the same to their students whenever required the courses on offer

a. The general terms of cooperation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2: SCOPE OF THE MOU

- 2.1 Student Community: The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close cooperation between the two would be of major benefit to the student community to enhance their skills and knowledge mainly in the Areas of Soft Skill development.
- 2.2 Curriculum Design: Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.
- 2.3 Industrial Training & Visits: Keeping in mind the Soft Skills Scenario, the Second Party also permits the faculty and students of the First Party to participate in similar training program imparted by the Second Party at other deemed institutes.
- 2.4 Internships and Placement of Students: Second Party shall provide time-to-time paid internship opportunities to some of the potential students of the First Partyif and only if participating candidates are eligible and have completed the trainings. The Internship is for a minimum duration of 3 months and can be extended up to 6 months on a case basis, with a nominal registration fee.
- 2.5 Research and Development: Both Parties have agreed to carry out the joint research activities in the field of Soft Skills and Life Skills development and similar activities based on Industry Scenario.
- 2.6 Skill Development Programs: Second Party to train the students of First Party on the emerging technologies related to Soft Skills in order to bridge the gap and make them industry ready.
- 2.7 Guest Lectures: Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements related to Soft Skills.
- 2.8 Faculty Development Programs: Based on the mutual discussion between the Management of First party and the Second Party, time to time review of the systems will be taken up and suitable performed by the second party based on mutually agreed terms and conditions.
- 2.9 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein.
- 2.10 There is no financial commitment on the part of the First Party to take up any program mentioned in the MOU. If there is any financial consideration, it will be dealt separately.

Nothing contained in this MOU shall, by express grant, implication, estoppel, or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copyrights and designs) of the other Party.

CLAUSE 4: VALIDITY

- 4.1 This Agreement will be valid for a period of 5 years up to 7th July 2028 from the date as governed by this MOU until it is expressly terminated by either Party on mutually agreed terms, during which period SUCCESS SCHOLAR, the Second Party, as the casemay be, will take effective steps for implementation of this MOU. Any act on the part of SUCCESS SCHOLAR, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under theterms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MOU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of KOLKATA.
